#### **About Energy 4 Impact**

Energy 4 Impact is a non-profit organisation seeking to reduce poverty in sub-Saharan Africa (SSA) by accelerating access to clean energy, helping businesses and communities make better use of that expanded access, and working with the private sector to support the sustainability of these efforts.

Energy 4 Impact values access to energy not as an end in itself but for the difference it makes to people's lives every day, in terms of agricultural development, economic growth, humanitarian recovery and climate resilience.

Supported by a small headquarters in London, Energy 4 Impact's team of 80 operates from regional offices in Kenya, Senegal, Benin, Tanzania, and Rwanda. Since our formation in 2006, Energy 4 Impact has supported over 8000 businesses and those businesses have created over 15,000 jobs, raised \$160 million and enabled 18 million people to get access to energy. Most of our income comes from major development agencies, development financing institutions and trusts and foundations.

**Energy 4 Impact is a subsidiary of Mercy Corps**, the global humanitarian and development organisation working to create a world where everyone can prosper. In more than 40 countries affected by poverty, climate change, crisis and disaster, Mercy Corps works alongside communities, local governments, forward-thinking corporations and social entrepreneurs to meet urgent needs and develop long-term solutions to make lasting change possible. Mercy Corps has over 5,600 team members and a total operating budget of \$488M and last year reached nearly 37 million people.

## About the Role

Energy 4 impact, in collaboration with Multiconsult, has been selected to support the Rural Energy Agency (REA)' s Rural Electrification Densification Program (REDP) by promoting productive uses of energy and stimulating energy demand in rural Tanzania. Over the next 18 months, Energy 4 Impact will provide business development support to local businesses in newly electrified villages in **Mbeya**, **Songwe and Arusha**, as well as financing facilities to micro-enterprises wishing to buy electrics tools and appliances. The aim of this collaboration is to enable the rural population to benefit fully from the expansion of the national power grid and stimulate economic development.

The project will target up to 600 local entrepreneurs connected to the national grid, with a particular focus on women, in approximately 194 villages. Energy 4 Impact will also provide technical assistance to Tanesco, REA and other Tanzanian stakeholders in order to prepare the ground for further upscaling of the Productive Use of Energy (PUE) program in Tanzania.

Energy 4 Impact is currently recruiting four Field Officers, one in each of the following locations: Arusha/Arumeru, Mbeya City, Kyela/Tukuyu, and Songwe. Each officer will undertake field-related activities in the regions of Mbeya and Arusha. The role involves supporting the entrepreneurs to make the most of the new power supply, and helping them overcome some of the barriers that hamper the growth prospects of their enterprises.

#### Responsibilities

- **Conduct field survey/study/assessments** to determine household/enterprise energy requirements, to gauge the technical, economic and social impact of productive uses for specific communities and its benefits within rural electrification projects, and to generate new business ideas powered by electricity.
- Propose interventions to implement appropriate productive use support activities.
- **Raise awareness** of various electricity applications beyond lighting, phone charging, powering TV/radio, and of the economic and social benefit of those applications.
- Organise workshops and consultations to help existing entrepreneurs identify new business ideas or expand or diversify existing activities (e.g computer rooms, TV/cinema rooms, phone charging, processing/refrigeration of locally grown agricultural crops or locally caught fish, or small-scale wood or metal workshops)
- **Identify and select** the most promising local entrepreneurs, with business ideas whose economic viability has been established, to receive support.
- **Mentor and support local entrepreneurs** to increase their sales by at least 30% over the implementation period.
- **Technical Assistance (TA):** provide technical assistance services in the form of technical training workshops and coaching to help entrepreneurs make informed decisions on selection and purchase of equipment, operation of the new equipment and machineries and basic maintenance.
- **Support enterprises to access finance** to invest in the electrical equipment and machineries required for their commercial activities. In collaboration with the Access to Finance team and the Project Manager, the field officer will identify the best option to access finance (whether though loans or other means). The field officer will also be responsible for the monitoring of loan repayments.
- Support entrepreneurs to access market activities by connecting entrepreneurs across the value chain, helping them to source new raw materials, facilitating linkages



with dealers operating at a regional or national level, organising visits to marketplaces or national trade fairs, etc.

- **Monitor and report** on key indicators as defined by the Project Manager and on the growth of local businesses supported through the programme.
- **Collect data** on a regular basis and feed into the M&E results system of the project including lessons learnt from implementation.
- Contribute to the preparation of regular progress reports and reviews
